As a condition of participating in the ThinkGeek Sweepstakes (the "Sweepstakes"), entrant agrees to be fully and unconditionally bound by these Official Rules and the decisions of ThinkGeek, Inc. ("Sponsor"), whose decisions shall be final and binding in all respects, and to waive any right to claim ambiguity in the Sweepstakes or these Official Rules.

1. ELIGIBILITY
